
The Department of Environmental Protection (the "Department" or "MassDEP") has completed its technical review of the Waste Volume Increase and the Waste Ban Compliance Plan permit applications listed above, and has determined that the applications are technically complete.

The enclosed Provisional Permits are issued pursuant to the provisions of 3120 CMR 19.037. Pursuant to 310 CMR 19.037 (4)(a), the MassDEP will accept written comments on these Permits for a period of thirty (30) days from December 12, 2011 till January 11, 2012. Subsequent to the receipt of any comments, the MassDEP will complete its review and issue final determinations regarding the permit applications by January 26, 2012.
